Sample Learning Opportunity #3

Name: Prevention Methods of Addiction

Domain: Cognitive and Affective

Target Population: Young Adults ages 18-25

Unit Objective: Following this unit, participants will recognize different prevention methods

and treatment options including how to reverse an overdose.

Enabling Objectives:

1. Following instruction, participants will list 5 signs and symptoms of substance abuse

disorder with a partner.

2. Following instruction, participants will name 4 personal reasons to abstain from drug use

in a journal.

Introduction:

Participants will enter the room with journals and pens/pencils at each seat ready for

them. A powerpoint will be open and ready to present once all participants are present and

seated. The instructor will introduce today's lesson and themselves. The powerpoint will then

begin and it will be discussing what participants will know about substance abuse, including

statistics, most commonly used drugs, and signs and symptoms of substance abuse disorder.

Following instruction will be the hands-on activity. The instructor will read the prompt as

follows: "You all will now open your journals and list 4 personal reasons as to why you yourself

should abstain from drug use." Following will be an open and optional discussion of what individuals have listed. If participants choose not to speak then the instructor will provide some examples themselves (ex. Better for mental and physical health, family/friend relationships, financial reasons etc.).

Description of implementation procedure:

- 1. Following the introduction there will be a presentation that discusses the following topics:
 - a. What you need to know: Facts and statistics regarding substance abuse (National Center for Drug Abuse Statistics. (2022, April 6). *Substance abuse and addiction statistics* [2022]. NCDAS. https://drugabusestatistics.org/)
 - b. Most commonly used substances: with examples of what kinds, how they're taken and or why they're used. (National Institute on Drug Abuse. (2020). *Common substances of abuse*. NIDA Archives.

- 2. Following the presentation will be a hands-on activity and participants will open their journals and list 4 personal reasons to abstain from drug use.

3. Following the hands-on activity, there will be an optional and open discussion with all

participants about what they had written in their journal. (If participants choose not to

participate then the instructor will provide some examples themselves).
